- Business must demonstrate innovation, viability and scalability
- Eligible to apply for Indefinite Leave to Remain after 3 years
- Minimum funding of £50,000 necessary (applicable to Innovator visa only)





SINCERE BUSINESS START-UP UK

To qualify for the Start-up or Innovator visa, the international entrepreneur must first receive an endorsement from a Home Office approved endorsing body. Endorsing bodies in the UK are Universities, Start-up accelerators and business development companies. Sincere has partnerships with various endorsing bodies in the UK and the pre-accelerator programme offered feeds into a number of accelerators to ensure the entrepreneurial enterprise has the best chance of survival in its early years of inception. Please ask your consultant for more details regarding assistance provided once you have successfully received both your endorsement and visa.

Our pre-accelerator programme prepares the international entrepreneur to be a founder of a venture that will demonstrate innovation, viability and scalability alongside global growth ambitions. These are the attributes endorsing bodies will look for throughout the venture's growth. 
